You may NOT mention other candidates in your manifesto, save that you may direct the electorate to support other candidates or to call for voters to transfer their preferences to other candidates (e.g. in NUS delegate elections, you may with voters to 2nd and 3rd preference others after they 1st preference you).

Word Limits: 400 word for Portfolio Officers and 240 words for all other elected posts (GSA, USSSA, NUS Delegates and Union Councillors).

You are invited to submit your election statement here now – but either way, it must by supplied typed up and within the word limit no later than 5pm Monday 16 November by email to elections@birkbeckunion.org.
